Other key considerations

- ▶ It is recommended to send materials for **600 participants**.
- ▶ When making the shipment, **you must prepay all associated costs**.
- ▶ **For shipments via courier, please consider the following instructions:**

Important: Upon arrival at the local FedEx or DHL office, please ensure that all charges—including freight, customs clearance fees, and local destination taxes—are duly covered to facilitate the release and delivery of the goods directly to our partner's local address.

DHL Shipping:

- **If the shipment has a value of up to \$200 USD**, it will not be subject to tax. In all cases, a fixed nationalization fee of \$13 USD must be paid, regardless of the product's value.
- **If the shipment has a value exceeding \$200 USD and up to \$2000 USD**, it will be subject to an IGV tax (18%), an IPM tax (2%), and the applicable customs duties based on the type of product.
- **If the shipment has a value exceeding \$2000 USD**, it will no longer be considered as regular cargo and must be processed under the definitive import regime with the assistance of our import specialists.

FEDEX Shipping:

- **Maximum dimensions** are set at **270 cm** in length or **330 cm** when considering **length plus girth**, and a **maximum weight of 70 kg** per package.
- **If the shipment has a value of up to \$200 USD**, it will not be subject to taxes. In all cases, a fixed nationalization fee of \$13 USD must be paid, regardless of the product's value.
- **If the shipment has a value exceeding \$200 USD and up to \$2000 USD**, it will be subject to an IGV tax (18%), an IPM tax (2%), and the corresponding customs duties depending on the type of product.
- **If the shipment has a value exceeding \$2000 USD**, it will no longer be considered regular cargo and must be handled under the definitive import regime with the assistance of our import specialists.

- ▶ **Attach a Commercial Invoice to your shipping documents**, By completing all the shipment details for sending your materials to Peru, the information must be expressed in U.S. dollars and must clearly indicate the value of the shipped product, as well as the product description, quantity, country of origin, tariff code, statement of use or purpose, cost, weight, and dimensions. You may request a commercial invoice template in the section corresponding to the courier you choose to send your packages with.
- ▶ **The estimated delivery times** are 3 to 6 business days for the Americas, 5 to 7 days for Europe, and 6 to 10 days for Asia, depending on the specific destination and the courier service used.

- ▶ **The shipment of perishable goods and medicines is restricted**, as well as hazardous materials without the corresponding certification and items that infringe intellectual property rights, through the courier service.
 - Cell phones and other similar devices require authorization from the Ministry of Transport and Communications (MTC), except in cases specified by a Directorial Resolution.
 - Medicines, vitamins, medical equipment, and other related devices require authorization from the General Directorate of Medicines, Supplies, and Drugs (DIGEMID).
- ▶ **Chemical products cannot be shipped via courier; they also require a procedure** that will be determined based on **their tariff classification**, involving both ADUANA and another public agency.
- ▶ **Products in general can enter Peru as normal air imports**, but it is always advisable to **inform the type of product and that they have the tariff heading, to verify the necessary procedures.**

For the **shipment of machines**, which must be of **Temporary Importation**, a company is required to carry out the procedures. For these cases, you can contact:

Note: As it is a TEMPORARY IMPORT, there is no tax payment but you must take into account the deadline established by ADUANA to return the merchandise to the country of origin.
